

Terms & Conditions

- The **Winter Shopping Festival** is a Winter Promotional Campaign, organized by **M/s Line Investments and Property - Sole Proprietorship L.L.C.** and applies exclusively to participating outlets in the following malls:
Abu Dhabi: - Al Wahda Mall, Khalidiyah Mall, Mushrif Mall, Mazyad Mall, Al Raha Mall, Madinat Zayed Shopping Center, Al Falah Central Mall, and Forsan Central Mall.
Al Dhafra:- Al Dhafra Mall
Al Ain: - Al Foah Mall and Barari Outlet Mall.
- A minimum purchase of **AED 200** from participating outlets during the campaign period, **6 December 2024 to 5 January 2025**, is eligible to qualify for participating in the raffle draw and scratch-and-win promotions. Purchases from hypermarkets within the malls are also eligible.

Digital Bills

- For late registrations, only printed copies of receipts will be considered valid.

Receipt Requirements

- Bill numbers must be clearly entered during registration.
- Each receipt must be stamped at the time of registration to validate its entry.
